Good interpersonal skills and the ability to engage effectively and positively with students and staff is a requirement.

They must be able to share ideas or examples of how they would successfully create an Arts Exhibition displaying students' art pieces through a variety of mediums and how they will promote the school's Visual Arts program throughout the community
